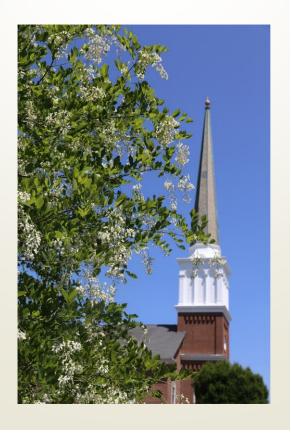

Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.

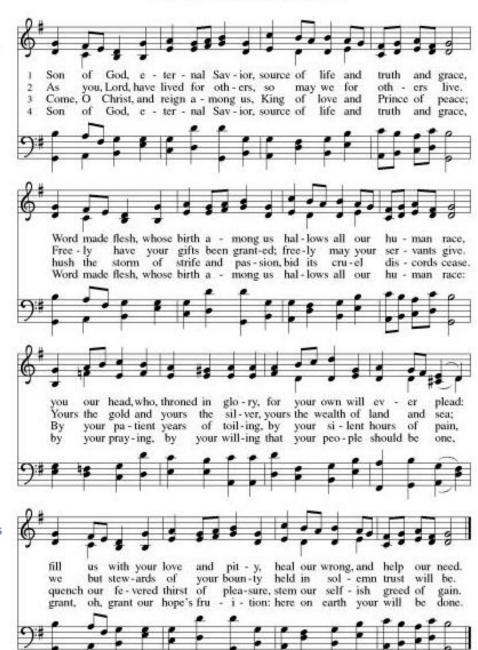
#### Receive our prayer, O God.

Last year my report focused on rebuilding the ministries after being shut down due to Covid. The majority of people are now back in church, and the ministries are back as well. However, I feel like we still have a way to go. So, amidst the winter white snow and cold weather we are having, that tends to slow us down in our daily activities, may we hear God's call to serve in those still quiet moments.

This past year at Jordan, we have landed on our feet well beyond other congregations in our synod. Our landing may not be a fast stick to earn us a ten in any gymnastic tumbling competition, but we have landed on our feet! Sometimes a little wobbly but always landing upright!

It is my prayer that as we be still and listen for God, that we are able to discern with enthusiasm what it is that God is calling us to do anew this coming year! Share your thoughts, concerns, and ideas.

I invite you to be involved in any manner you can! Let us share our stories of how God is present in your life, transforming you and others through the ministries we gather to do at Jordan. Be still and know God! Hear God calling you as you discern your involvement at Jordan both with your time and finances.

And to engage and encourage children, youth, family church members, and the community to participate in ministry programs and events to grow closer to God and one another throughout the year at Jordan Lutheran Church.

#### Sunday school

- God's children are all called to have a relationship with Jesus Christ. Our teachers encourage the children to seek a relationship with Him as they read the Bible stories. It was a blessing to have 20 children on the primary Sunday School roster, Pre-K to Grade 6 this year. Parents are to be commended for their dedication to bring their children each week to Sunday School. The class, led by five devoted teachers and five adult and youth volunteers, has implemented a successful rotating teaching schedule to present lessons, crafts, and songs with children throughout the year. The Sparkhouse Digital online curriculum is used to access weekly bible stories, with age-appropriate material for children.



- A Parent Handbook was designed to provide parents/guardians with information about our Sunday School program. The handbook shares dates and schedules, memorization goals and information about the weekly lessons taught in class. As children returned for Rally Day in September they took a backpack scavenger hunt, "Journey through the Books of the Bible". Each child received a backpack and Bible to begin their journey. Same day included a Grandparents Day celebration, "Goodies with Grands" to honor grandparents.
- Teacher Installation was held for members to offer their support to teachers and assistants as they dedicate time to teaching the Sunday School classes.
- A joyous Youth & Children's Christmas program, "The Christmas Checklist" was presented by 10 children, 6 confirmation students, 4 youth, teachers, adult members, and the congregation joined in singing several beloved Christmas carols.

#### **Confirmation Ministry**

The confirmation class, taught by two teachers, has 10 students on the class roster. The students submitted sermon notes to the pastor, attended church and Sunday school each week, participated in weekend retreats, and visited a local synagogue. Three students, Jordan Kerschner, Gavin Schuler and Connor Weidman were confirmed this year. Currently four students are preparing to be confirmed in the coming year. The students also served as acolytes and bell tollers during the worship services and participated in additional church and community service activities. Parents are to be commended for their commitment to submit monthly progress reports to note the attendance, community service and credit hours of their children. The students are blessed with assigned mentors giving them accountability and support.

#### <u>Youth</u>



- -The youth oversee the donated clothing bins, storing bags throughout the year. These students help load bags onto a truck collecting the donations. The money received for the clothing donations is for the youth fund to attend activities.
- -A "Backyard Picnic" an afternoon gathering, held on Rally Day, for students 8-15 to enjoy sports, games and lunch.
- -The youth actively participated in organizing the Egg Hunt, stuffing and hiding eggs, and performed a skit for the children.
- -A chilly night of "Glow Golf" was held at Bear Creek Junction, three families attended a night golfing in the dark.

- -The youth invited members to participate in gift-wrapping empty shoe boxes during God's Work Our Hands (GWOH). Later the boxes were filled by the members and given to the Holiday Hope Chest organization to support and provide happiness to our local community children during the holiday season.
- -Youth also prepared seasonal bags, cards and notes for shut-ins throughout the year.
- -Youth have been informed and invited to attend Bear Creek Camp sessions offered throughout the year.
- -Youth have been informed throughout the year of the ELCA Youth Gathering in New Orleans, July 16-20, 2024.

#### Vacation Bible School



Vacation Bible School titled, "Babylon" was held June 19-23, 2023. A total of 25 students, ages 5-11 attended the week's program. Amber Kerschner served as Director, 11 adult volunteers and 10 youth helped create a fun and memorable week for all who attended.

In 2023, the Committee continued to remain invested in exchange trades funds (ETF's) through Valley National. That resulted in savings on broker fees which have negatively impacted returns in the past.

At the Joint Endowment Committee meeting in January 2024, the Endowment Disbursement/Marketing Committee and the Endowment Investment Committee approved a disbursement of \$15,284.

The return on investment for 2023 was 12.52% as compared to -15.50% for 2022.

The disbursements to the disbursement committee will be forwarded in two equal payments (or as needed) in January and July of 2024.

The portfolio is managed by Valley National Advisers, Inc. in accordance with Jordan's by-laws and the Committee's investment policy, The majority of the portfolio is invested in exchange traded funds, with a portion also invested in the ELCA Mission Fund.

In 2020, a member of Jordan, assigned ownership and beneficiary of a whole life insurance policy to Jordan. with a death benefit of \$100,000, Jordan will make the future annual premiums on the policy and the member will gift the premiums to cover the annual premiums. The intent of the donor of policy is that the proceeds of the policy and/or cash value will be part of the Jordan Endowment Investment Fund.

The Committee held quarterly meetings, as required by the bylaws and participated in the annual joint endowment meeting.

#### **GRUNDSAU LODSCH NU. 16 AM JAHDEN**

Information of the beginning of Ground Hog Day. One of the ramifications of the First World War was the resentfulness the American people felt toward those that portrayed their German culture, traditions, and language, particularly in their churches and schools. This was a heartfelt and distressing shock especially to the Pennsylvania German communities in the eastern part of the state. The fear of their future generations losing their ethnic heritage prompted a group of men to find a way to preserve the customs of their birthright. William Troxell, Rev. Thomas Brendel, Dr. Edgar Balliet, and Harry Spannuth thought that forming a ground hog lodge would be a solution to their dilemma.

Groundhog Day started on February 2, 1887. Introduced to America by German settlers, the tradition rendered the use of a hedgehog in Europe for many centuries. A groundhog became the animal of choice to this area because of its abundance in Pennsylvania. At a private gathering on April 3, 1933, the men's plans were finalized to form the first groundhog lodge, determined to meet annually every February 2, on Groundhog Day. Pennsylvania German men would gather not only to witness the "weather report," but to maintain their ethnic pride with food, stories, songs, speeches, play acting, all to keep their customs and traditions alive.

This lodge was organized at Jordan Lutheran Church over 50 years ago. Several of the founding men were members of Jordan Lutheran Church. Over the years, their main activity was a dinner held approximately 6 weeks after Groundhog Day. The dialect is spoken including discussion on what the weather prediction had been on Groundhog Day. The evening includes a PA Dutch dinner, singing PA Dutch songs, telling stories, and meeting acquaintances. The March 2023 event was held Friday night, March 3, 2023 at the Social Hall of the North Whitehall Ambulance Corp. (NOVA). This was the first year the board of the lodge had decided to allow women to purchase a ticket and attend this annual event. Approximately 20 women attended and enjoyed the evening.

Besides the annual dinner, the lodge hosts a weather prediction event at Wehr's Dam Park at 7:00 a.m. on February 2, Groundhog Day. During the gathering, our groundhogs, Jahde and grandson, Lee come across the Jordan River via a raft on the river. Upon arrival, Jahde reveals what is in store for the next six weeks via Lee speaking to Haaptmann Dave Adam. Will spring arrive early or will we have six more weeks of winter? The event is open to anyone willing to brave the cold weather and early hour. Coffee, hot chocolate and cookies are offered to everyone in attendance.

#### ORGANIST, CHOIR DIRECTOR, AND BELL CHOIR DIRECTOR

Goals are to continue presenting meaningful and worshipful musical leadership by all ensembles to enhance worship.

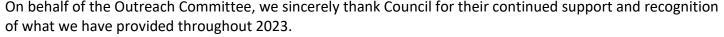
#### **OUTREACH COMMITTEE**

#### PA DUTCH CLASS IN JORDAN'S SOCIAL ROOM

#### Treasurer's Report for Calendar Year 2023

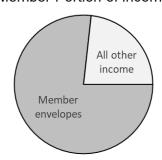
As the following summary report shows, the church ran a deficit of nearly \$30,000 in 2023. In round numbers, property expenses exceeded budget by \$10,600. The lion's share of this consisted of the \$9,900 that was spent to seal the parking lots. This was better than 2022, when we had many expensive repairs. Expenses excluding property were \$3,300 under budget. The main difficulty in 2023 was that operating income was \$410,500, which was \$22,600 less than we had estimated it would be. This is always difficult to estimate, but we did not do very well this year. It was especially disappointing because operating income in 2022 was \$436,500.

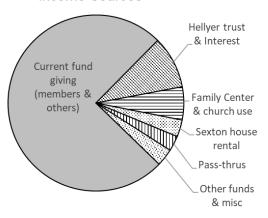

#### Income Sources

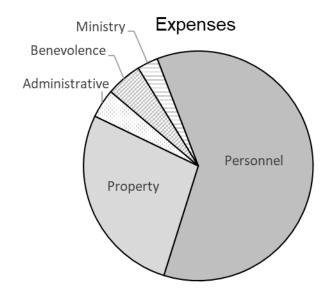


The chart at left shows the sources of church income, regardless of whether from members or nonmembers. 2023 number excludes the ventilation grant.

The chart at right shows the expenses for the church in 2023.

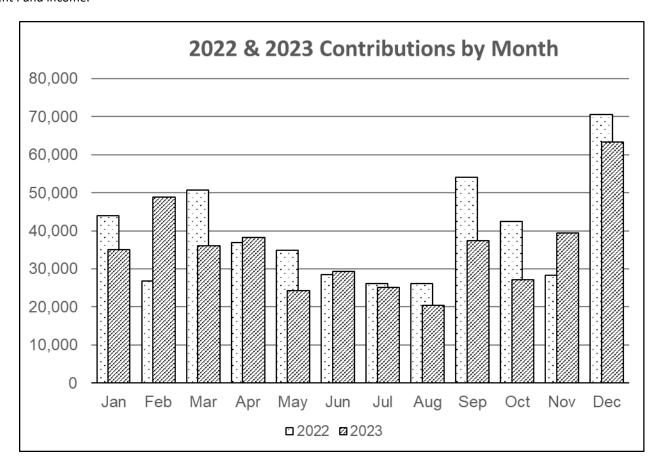

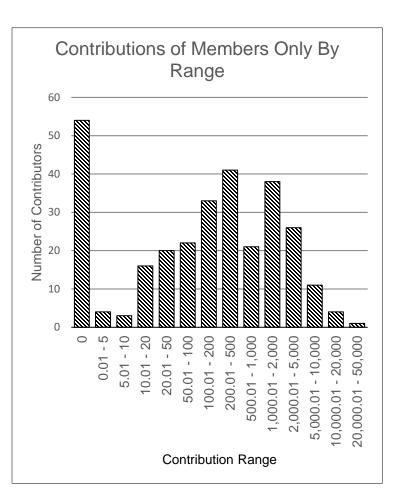

#### Financial Details:

#### Explanation of church income and expenses:

The income reported in the "Funds Report" shows *all* money that came into the church during 2023. Most of this money goes into the Current Fund, consisting of all of the accounts that are part of the Income and Expense Report. This is the money used to meet the day-to-day expenses of the church. However, not all church income goes into the Current Fund, as explained below.

Sources of income include money for not only the Current Fund, but all other Funds in the church accounting system (examples are the memorial, pantry, youth, etc.). These Funds have their own income and expense accounts separate from the Current Fund, and the money in these funds is used for purposes relating only to these funds.

#### Income sources are:

- Member contributions (through envelope offerings). The major contributions in this category would be current fund, property, benevolence, pantry, memorial fund, etc. It also includes special offerings such as Communion, Christmas and Easter flowers and offerings, etc.
- Nonmember contributions, which is any contribution that cannot be attributed to an envelope number.
- Use of church facilities, such as the Family Center. These are almost all nonmember contributions.
- There are some nonmember contributions to the memorial fund, such as from friends and family that are not members of Jordan.
- Income from the Magaret Hellyer Trust. This is nonmember income.
- Rent from the Sexton house is nonmember income.
- Income from interest on a savings account and a certificate. This is nonmember contribution.
- Passthru accounts. This is money that is given to the church but will be paid out again. Although it is included in income, it cannot be used to pay expenses, because it is already dedicated to another use. Examples include contributions to ELCA World Hunger and Disaster aid, which gets paid on to the Synod. Other examples from 2023 would be money for Iron Pigs tickets, contributions for the spaghetti dinner for the Haafsville animal shelter, and the basket social (which was sent on to Parkland CARES). Income for the passthru accounts is a mixture of member and nonmember contributions. It does not appear in the current income or expense accounts.
- Other accounting Funds, such as Memorial, Pantry, and Youth funds, etc. Money contributed to these funds does not
  appear in the current income or expense accounts (because they have their own income and expense accounts, separate
  from the current fund). Money in these funds comes from members and nonmembers.

Note that because income for the passthru and other accounting funds does not appear in the Current Fund, the income reported in the Current Income and Expense Report is less than the total income reported in the Funds Report.

For anyone who looks closely at the financial reports, there are two income items that merit special explanation.

First, the church received a grant from Lehigh County to make improvements to the ventilation in the sanctuary. The grant was \$25,000. It appears as income, but it is just sitting in its own fund awaiting further action on ventilation upgrades, and that is the only thing it can be used for. Because it is such a large amount, it tends to distort the income picture, so I have excluded it from all the charts and graphs in this report. It appears in the Fund Balance report.

The second item appears in the Income and Expense Report. At the beginning of 2023 I did some housecleaning in the passthru accounts. There was undisbursed money for World Hunger, there was some from our 285<sup>th</sup> anniversary celebration that had not been spent, and some other accounts with small negative balances. With Council approval, accounts with positive balances were used to cancel negative balances, the World Hunger money was sent to Synod, and the accounts all cleaned up. After this, there was still about \$2,100 left over that was transferred to the Current Fund. Later in the year, when we needed to pay to have the parking lots sealed, we transferred \$9,500 from the memorial fund to the Current Fund. These two transfers appear in the Income and Expense Report as an \$11,607 "Transfer from other funds". This appears as income, but it came from other church accounts, not from contributions.
